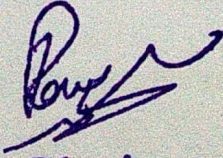

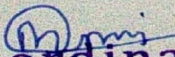

- 3) It was resolved that to complete the construction of new building and humble appeal was made to all the faculties and administrative staff to raise the fund and to assist with financial aid.

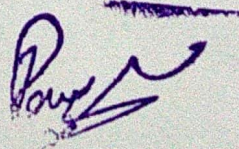
