The following points were discussed in the meeting:

- 1) Minutes of the last meeting were confirmed.
- 2) The NAAC Peer Team visited the college on 4-5th August, 2021. After successful visit and assessment on 7th August, 2021, NAAC result was declared on portal and college received **A+ Grade** with **3.26 CGPA**. In this meeting the Exit Meeting Report was opened and presented before the committee. Criterion-wise analysis was elaborated to the members and SWOC analysis and the PTV recommendations were reiterated for the further improvements
